<u>2016 Park Millage</u>: Patton distributed millage spreadsheets detailing facts about the new Park millage language that will appear as two questions on the November 8 ballot. He also reviewed completed Park

projects for 2010-15, new Park projects proposed if the additional millage passes and a cost analysis for wages and benefits versus other expenses at the Park from 2010-14. The YES! YES! Park millage committee met on August 19 and meets again August 30 at the Barry County Central Dispatch Center. Gibson mentioned hosting a Park Millage informational meeting at the Commission on Aging. Brian Reynolds offered his business location in downtown Hastings as a space to hand out millage information during Hastings Summerfest. Hale mentioned that she will distribute Park information at the Hastings Farmer's Market. Park representation would also be appreciated at the World's Longest Ice Cream Sundae on Sept. 17 in Nashville. Moore initiated discussion regarding Barry County Township Board meetings.
